ORDINANCE NO. 1258, SERIES 2010

AN ORDINANCE RELATING TO AMENDMENT OF SECTION 111.16:
LICENSE FEES, OF THE CITY OF JEFFERSONTOWN, KENTUCKY CODE
OF ORDINANCES RELATING TO TEMPORARY LICENSES FOR MALT
BEVERAGES, WINE AND DISTILLED SPIRITS

WHEREAS, the Jeffersontown City Council is cognizant of issues associated with vendors who are not licensed with the City of Jeffersontown for the sale of malt beverages, wine and distilled spirits on an annual basis, who obtain Temporary Licenses; and,

WHEREAS, there are increasing requests for licenses during special events, resulting in increased enforcement and administrative monitoring.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Jeffersontown, Kentucky that the City Council does hereby AMEND Section 111.16 to state in its entirety by adding thereto the following:

Section I: Chapter 111.16: *License Fees*, of the City of Jeffersontown, Kentucky Codified Ordinances is hereby amended as follows:

~~(G) Special temporary distilled spirits, per month or part of month—1/6 of fees enumerated in divisions (E) or (F) above;~~

(G)(1) Special temporary license, per month or part of a month, for a person, firm or corporation holding a license to sell distilled spirits at retail within the corporate boundaries of Jeffersontown, Kentucky - \$12.50.

(G)(2) Any person, firm or corporation not holding a license to sell distilled spirits at retail within the corporate boundaries of Jeffersontown, Kentucky - \$600.00.

(K) Malt beverage retailers license.

(3)(A) Special temporary license, per month or part of month, for a person, firm or corporation holding a license to sell malt beverages at retail within the corporate boundaries of Jeffersontown, Kentucky – \$ 12.50.

(B) Any person, firm or corporation not holding a license to sell malt beverages at retail within the corporate boundaries of Jeffersontown, Kentucky – \$ 600.00.

(L) Restaurant Wine License (subject to the provisions of KRS 243.032)

(L)(3) Special temporary license, per month or part of month, for a person, firm or corporation holding a license to sell wine at retail within the corporate boundaries of Jeffersontown, Kentucky – \$ 12.50.

(L)(4) Any person, firm or corporation not holding a license to sell wine at retail within the corporate boundaries of Jeffersontown, Kentucky – \$ 600.00.

Section II: Any Ordinance or parts of Ordinances conflicting with the provisions of this Ordinance are repealed in so far as same affect this Ordinance.

Section III: This Ordinance shall take affect and be enforced immediately upon its passage and publication.


