Sign Permit Fees

ATTACHED and/or FREESTANDING SIGN FEES

First Sign on Permit Application	
Twenty five (25) square feet or less	\$20.00
More than 25 square feet	\$20 + \$2 per sq. ft. over 25 sq. ft.
Each Additional Sign per Permit	
Twenty five (25) square feet or less	\$10.00
More than 25 square feet	\$10 + \$2 per sq. ft. over 25 sq. ft.

MAXIMUM FEE PER SIGN IS \$200.00

Double faced signs are considered one sign.

TEMPORARY SIGN REQUIREMENTS

(Mobile signs, trailer signs, banners, etc. and **NOT** exceeding thirty-two (32) square feet.)

FEE: Twenty (\$20.00) Dollars

Permits **ARE** void fifteen (15) days after issue date.

A refundable deposit of Fifty Dollars (\$50.00) **IS** required.

Signs utilizing luminous or colors capable of change due to refraction are **NOT** allowed.

Signs utilizing electricity are **NOT** allowed.

Shall **NOT** be placed closer than five (5) feet from any right-of-way.

A **WAITING PERIOD** of sixty (60) days is required between applications.

SMALL FREESTANDING BUSINESS SIGN REQUIREMENTS

(“Sandwich Style” sign in Town Center Form District only)

FEE: Twenty Dollars (\$20) up to twelve (12) square feet.
